FUNDRAISERS COPY

- A. Anderson's Frozen Custard agrees to sell Coupon Books to said organization for \$1.00 each. Organization agrees to sell books at no higher than \$4.00 each.
- B. Organization must present official letterhead stationary as proof of group's existence.
- C. MINIMUM number of Coupon Books signed out at initial contract signing will be 50. (Must sell at least 50 books during contract dates.)
- D. Anderson's agrees to take back unsold Coupon Books that are in perfect, clean saleable condition. ** (To be determined by AFC personnel.) Books must be returned within 45 days of initial contract signing to qualify for credit towards invoice.
- E. Said organization may sign for up to 100 books without initial payment. Credit will be extended for the first 100 books only without initial payment. Payment is due thereafter. For initial installment, see F.)
- F. Payment for at least 50% of initial installment MUST be made BEFORE more books will be handed out for sale.
- G. Outstanding balance cannot exceed more than 50% of current books on consignment.
- H. Fund raising Program will conclude no more than 45 days from initial signing of contract. At the end of 45-day period, said organization shall pay AFC. Inc. in full for remaining balance as per invoice tracking record.
- I. Anderson's agrees to give each group prizes according to sales tier. (To be disbursed as advisor sees fit). Tier is based on total sales at end of program. No dividing sales into sub tiers.) Prize Certificates will be mailed within 3 – 4 weeks upon closing of account.
